# 1. The Pennsylvania Key - Preschool Development Grant Birth Through Five - PDG B-5 - Program 23-286

Office of Professional Learning

7/1/23 - 6/30/26

This program consists of a federal grant from the Department of Health and Human Services passed through Pennsylvania Department of Education to OCDEL and the BCIU PA Key to accelerate systems-building to benefit priority populations including infants, toddlers, vulnerable children, children transitioning to kindergarten, migrant families, children with special needs and the ECE workforce who serve children & families across PA. Major initiatives

Major initiatives the PA Key is focusing on include bringing on additional staff to support Mental Health and Professional Development, Needs Assessments Projects, Marketing Campaigns, Building Coach Capacities, Homelessness projects and Rapid Response Grants.

### **B.** Initial Budgets

### 1. Education of Children and Youth Experiencing Homelessness – Program 23-150

Office of Early Childhood and Student Services 7/1/23 - 6/30/24

\$806,762

The BCIU has been allocated the above amount to manage Region 2 of the PA Education for Children and Youth Experiencing Homelessness Program through PA Department of Education. There are eight grantees in the Commonwealth that receive McKinney-Vento funds to form a management team that provides all public-school districts in the Commonwealth a regional office to oversee compliance issues and assist with homeless student identification and data management. Region 2 consists of Berks, Chester, Dauphin, Lancaster, Lebanon, and Schuylkill counties. The grant is in the third year of a five-year period. This program is funded by federal dollars and has been existence since 1992/1993.

# 2. Project ELECT/Fatherhood Initiative (Education Leading to **Employment and Career Training) – Program 235**

Office of Early Childhood and Student Services 7/1/23 - 6/30/24

\$659,532

Funded by state, local, and federal monies through the Family Support Act which is designed to enable families with dependent children to become financially independent of public assistance, this budget helps ELECT participants to complete high school and train for a job. Additionally, the fatherhood initiative provides education resources to custodial and non-custodial fathers under the age of 22 who are enrolled in middle school, high school, or GED programs (since 1993).

### 3. Special Education Contracted Services – Program 302

Office of Early Childhood and Student Services 7/1/23 - 6/30/24

\$6,541,272

This proprietary program provides local school districts with special education instructional programs and services including Deaf & Hard of Hearing classrooms, Life Skills Support classrooms, Interpreter services, and Itinerant services (since 1991).

### 4. Special Education Core – Program 304

Office of Early Childhood and Student Services 7/1/23 - 6/30/24

\$3,434,735

Funded by the Pennsylvania Department of Education, this budget covers costs for management, federal/state mandates for special education, direct services, child tracking (Penn Data) services, and administrative functions designed to support the Special Education programs throughout the Berks County Intermediate Unit and our school districts (since 1991).

### 5. Tower Behavioral Health - Program 624

Office of Early Childhood and Student Services 7/1/23 – 6/30/24

\$400,491

The Tower Behavioral Health Program is a licensed in-patient hospitalization program for behavioral health treatment, serving students through crisis, emergency hospitalization, parent referrals, community agency referrals, and school district recommendation. Students receive counseling services provided by Tower Health staff. Educational services and social skills instruction are provided by BCIU staff. There is coordination with the students' hospitalization treatment team and resident school district to provide a continuum of academic support with efforts focused on maintaining students' progress in their home district's curriculum. The educational component is funded by the resident school districts of the students (since 2021).

### 6. Alternative Education Program - Learning Academy at Thomas Ford - Program 626

Office of Early Childhood and Student Services

7/1/23 - 6/30/24 \$3,352,946

This proprietary program provides alternative education services at Learning Academy at Thomas Ford to students from grades sixth through twelve. A full range of academic courses are provided and there is close staff collaboration with juvenile probation, children and youth services, Service Access Management (SAM), community mental health providers, and drug and alcohol agencies (since 1995).

## 7. Head Start State Supplemental Assistance Program – Program 170

Office of Professional Learning

7/1/23 - 6/30/24 \$758,048

Funded by the Pennsylvania Department of Education and the Head Start State Collaboration Office, and facilitated by The Pennsylvania Key staff, this program provides monitoring and technical assistance to Head Start State Supplemental grantees throughout the state (since 2005).

### 8. Early Childhood Mental Health Initiative – Program 223

Office of Professional Learning

7/1/23 - 6/30/24 \$905,821

Funded through BCIU's IDEA Section-619 and State Early Intervention grants, and facilitated by The Pennsylvania Key staff, this program provides funding for Early Childhood Mental Health Consultant Specialists to provide targeted mental health support and monitoring to pre-school children in Pre-K Counts and Head Start State Supplemental programs throughout the state (since 2009).

### 9. PA Pre-K Counts - OCDEL - Program 228

Office of Professional Learning

7/1/23 - 6/30/24 \$2,667,201

Funded by the Pennsylvania Department of Education, and facilitated by The Pennsylvania Key staff, this program provides monitoring, technical assistance, consultation, and training and materials for all Pennsylvania Pre-K Counts approved providers (since 2007).

### 10. Berks Online Learning - Program 680

Office of Professional Learning

7/1/23 – 6/30/24 \$446,156

This proprietary program is a partnership between BCIU and multiple cyber course providers to offer local school districts online education options for K-12 students (since 2008).

### 11. Emergency Connectivity Fund – Program 219

Office of Information Technology

7/1/23 – 12/31/23 \$106,991

BCIU through a grant with Universal Service Administrative Company (USAC), will purchase services required for implementing Wi-Fi/Internet access on 147 buses from three vendors. This project will provide filtered, mobile broadband access to students while riding Berks County Intermediate Unit buses to help bridge the digital divide.

### 12. BCIU Print Service Center – Program 605

Office of Information Technology

7/1/23 - 6/30/24 \$536,803

This proprietary program provides printing and duplicating services to school districts and to all BCIU departments and programs (since 1980).

### 13. Special Education Transportation – Program 344

Office of Operations

7/1/23 - 6/30/24 \$11,004,202

Funded by the state, this budget provides for the transportation of approximately 2,563 special needs children between their homes and schools and activities prescribed by the individual education program (since 1969).

The BCIU has been allocated the above amount to manage Region 2 of the Educational Stability for Foster Care Youth program through the PA Department of Education. There are eight grantees in the Commonwealth that receive these funds to form a management team through regional offices. The goal of the regional office is to provide technical assistance, training, and support to all public-school districts and county children and youth agencies with regards to the education of children in foster care. Region 2 consists of Berks, Chester, Dauphin, Lancaster, Lebanon, and Schuylkill counties. The grant is allocated through Title I, Part A funds annually (since 2017). These changes are necessary to due to additional funding.

### 2. Head Start - Program 23-165

# Total Proposed Revised Budget: \$8,679,897

The 2023 Head Start Program is funded primarily by federal dollars, which are distributed by the Department of Health and Human Services, Administration for Children and Families. Additional funding is received through the Child and Adult Care Food Program. These funds will serve approximately 610 children in 35 classrooms across Berks County. This program has been in existence since 1965. This change is necessary due to a cost-of-living adjustment.

### 3. Early Head Start Child Care Partnership - Program 22-168

Office of Early Childhood and Student Services 8/1/22 – 7/31/23

\$44,450

### **Total Proposed Revised Budget: \$624,565**

The Commonwealth of Pennsylvania, Office of Child Development and Early Learning (OCDEL) has contracted with the BCIU to partner with two local Child Care Centers to provide Early Head Start services. The Early Head Start Child Care Partnership (EHS-CCP) will provide full-day, full-year services designed to promote the development of young children from birth to three. Early Head Start promotes the school readiness of low-income children (since 2015). This change is necessary due to additional funding for the Early Head Start partners.

## 4. The Pennsylvania Key - American Rescue Plan Act– Program 22-128

Office of Professional Learning 2/1/22 – 9/30/24

Total Proposed Revised Budget: \$17,429,617

\$314,931

As a result of the American Rescue Plan (ARP), The Pennsylvania Key has been awarded a supplemental grant for activities in response to COVID-19. The supplement contains funding for projects that will improve professional development and technical assistance for all preschool, childcare, and Head Start Centers.

Services under this agreement will include assistance in the facilitation of initial information gathering and creation of a landscape report, stakeholder engagement sessions, steering committee, writing workgroups, community feedback, and presentation to the State Board of Education. BCIU will support and supply technical assistance to the Pennsylvania Department of Education throughout the revision process (since 2019). These transfers are necessary due to year-end adjustments.

### 4. Berks Business Education Partnership Grant – Program 22-282

BCIU through an agreement with the County of Berks will provide contracted services to recruit businesses to be part of the Career Ready Berks platform, implement Career Pathways Advisory Groups, plan professional development on workforce trends and provide a community leadership forum to share current Career Ready Berks initiatives, updates, and next steps as a means of building business-education collaboration and support for Berks County educators and nearly 70,000 students (since 2019). These transfers are necessary due to year-end adjustments.

BCIU's services will include the recruitment, hiring, logistics, and supervision of the Director of School Improvement Performance Management and Assistant Directors of School Improvement Performance Management.
